**Michelle Henry**

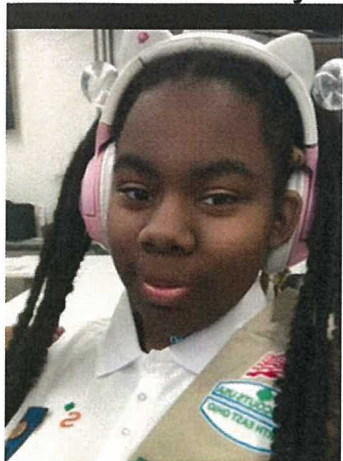
